- 1. Extended abstract should be submitted in word document, latest by 7th November 2022 to sifico.kjsim@somaiya.edu
- 2. Authors must send extended abstract (Minimum 1000 words) using following guidelines:
  - Title
  - Purpose of the study
  - Research Objective
  - Research Design
  - Findings
  - Implications
  - Limitation
  - Keywords
- 3. Extended abstract should be in word document format, Times New Roman,12-point font size with single line spacing, 1 inch margins and APA style of referencing the citations.
- 4. Authors are requested to adhere to the guidelines of the extended abstract on submission.
- 5. Please note that the Institute has a strict anti-plagiarism policy so originality of the work should be ensured by the authors.
- 6. All the selected extended abstract will be published as Conference Proceedings with ISBN number.
- 7. Upon acceptance of the abstract the author(s) agree to release the copyright to the 12th SIFICO
- 8. All abstracts will be double blind peer reviewed.
- 9. Subsequent to the conference presentation, authors can submit full paper on the publication partner portal




# K J Somaiya Institute of Management
