



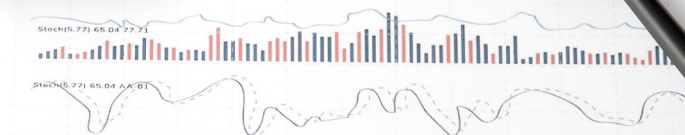
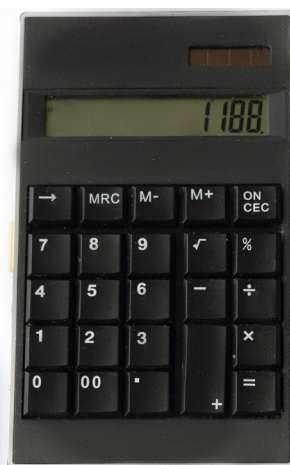

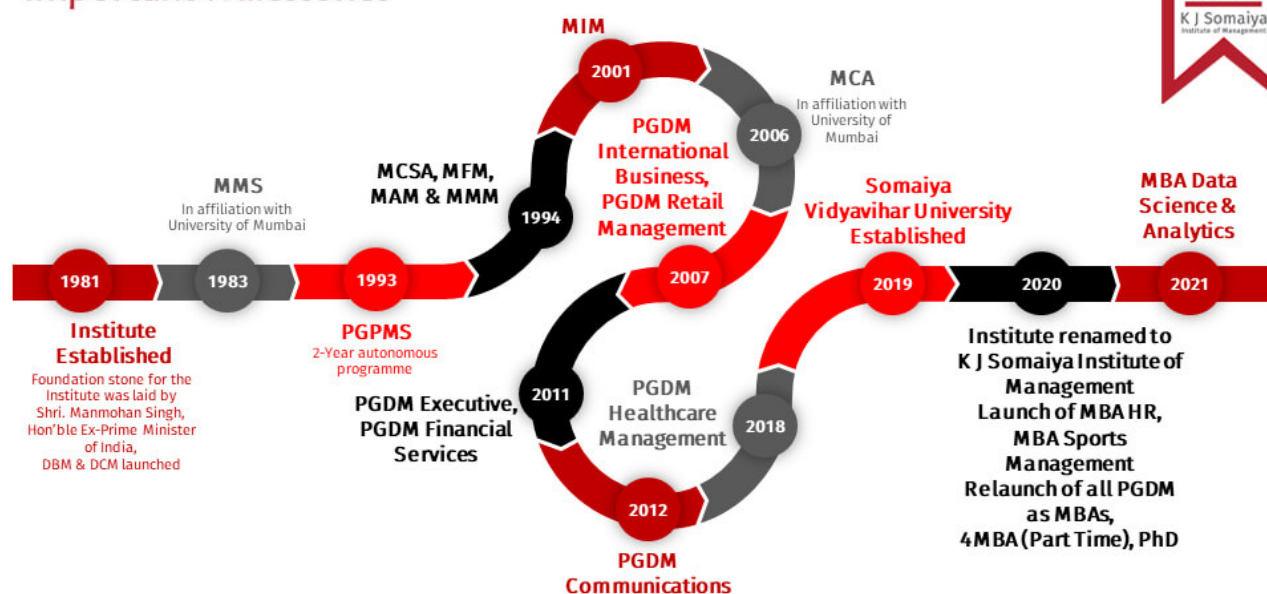

Extended Abstract and Paper Submission Guidelines

Extended abstract should be submitted in word document, not later than **15th October 2021** to sifco.kjsim@somaiya.edu.

Authors must send extended abstract of not more than 1000 words using following guidelines:

- Title
- Purpose of the study
- Research Objective
- Research Design
- Findings
- Implications
- Limitations
- Key words

Extended abstract should be in word document format, Times New Roman, 12-point font size with single line spacing, 1 inch margins and APA style of referencing the citations.

Authors are requested to adhere to the guidelines of the extended abstract on submission.

Please note that the Institute has a strict anti-plagiarism policy so originality of the work should be ensured by the authors.

By submitting an abstract, the authors make a good faith commitment to present his/her paper at the conference. Names of the authors, their addresses (postal and email) and phone numbers should also be indicated.

All abstracts will be double blind peer reviewed.

All the selected extended abstract will be published as Conference Proceedings.

Subsequent to the conference presentation, authors can submit full paper on the publication partner portal.

Publications Opportunities

SIFICO 2022 has tied up with 'International Journal of Global Business and Competitiveness', a Springer Journal listed in ABDC 'C' category. Publication of papers presented and submitted by delegates is subject to review by reviewers of the journal and the final decision for publication is with the Editor of the journal.

There will be a free Pre-conference workshop on 21-1-2022 for all the participants who registers for SIFICO 2022.

Best Paper Award

Two selected papers shall receive the Best Paper Awards nominated by the jury after carefully scrutinizing all aspects of the paper.
