This has reference to the proposal submitted by K.J. Somaiya Institute of Management Studies & Research, Vidyavihar, Mumbai-400 077 Maharashtra affiliated to University of Mumbai, Mumbai for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

The Standing Committee in its meeting held on 16.01.2019 decided to grant extension of autonomous status to K.J. Somaiya Institute of Management Studies & Research, Vidyavihar, Mumbai-400 077 Maharashtra affiliated to University of Mumbai, Mumbai, for a period of ten years w.e.f. 2019-2020 to 2028-2029.

Further, it may be noted that the above said college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.


