Introduction



MUMBAI

- Mumbai is the "City of Dreams" due to the presence of prominent industries of finance, commerce, and entertainment and people from all walks of life. Mumbai has Fortune 500 Companies, Bombay Stock Exchange, Reserve Bank of India, and Mumbai World Trade Centre.
- Bombay Stock Exchange (BSE) was established in 1875, is Asia's First & the Fastest Stock Exchange in world with the speed of 6 micro seconds and one of India's leading exchange groups. BSE is the world's fourth largest equity market.
- Mumbai's cultural richness is exemplified by the UNESCO World Heritage sites. Mumbai has the largest transportation infrastructure in India, it varies from local trains, buses, taxi, autorickshaws to airlines and ferry routes.

In the year 2022, Mumbai recorded a gross domestic product of 310 billion U.S. dollars, the highest among major cities in India.

Mumbai is the world's eighthmost populated metropolis having a population of 20 million as of February 2022.






GERMANY

The statistics from the Federal Statistical Office of Germany, the number of Indian students pursuing higher education in Germany has increased by 26% in the last year, reaching 42,997 for the Winter Semester 2022-23.

Germany is one of the most sustainable industrialised nations in the world, excelling in areas such as growth, employment, social security, and environmental preservation. The country's dedication to sustainability enhances its appeal as a desirable location for international students seeking high-quality education and a supportive atmosphere for personal and academic development.

As the 5th most popular destination for international students, Germany holds a prominent position in global education.

Times Higher Education recognizes Germany as the second-affordable country in Europe for studying. With a remarkable educational landscape, Germany boasts over 380 universities offering a diverse range of more than 17,000 study programs.

According to World Bank Data, Germany has a GDP of 4.26 lakh crores USD (2021), establishing itself as the largest economy in the European Union. The bilateral trade between Germany and India is reported at \$26,061, as per the Ministry of External Affairs, Government of India.
